Budget Proposal Hits Rivers Hard

Recently Governor Romney unveiled his plan to reorganize the state's environmental agencies and dismantle or severely reduce the budgets for several important environmental programs. With the state in a financial crisis, budget cuts are unavoidable, but the Governor's budget has a disproportionately large impact on the environmental programs which make up a minuscule portion of the state budget. Of even greater concern, several of the state's most effective programs have been cut all together, further magnifying the impact to services, and in some cases forfeiting substantial matching funds. The time is NOW to tell your state legislators that you want clean, safe and abundant natural resources that we can enjoy and rely on for generations to come!

There are several items within the proposed 2004 budget that are of particular concern. For example, The Natural Heritage and Endangered Species program will lose \$200,000 of its budget and will be forced to transfer the endangered species permitting operations to the new Division of Environmental Protection, effectively removing wildlife biologists from permitting decisions. Likewise, the fees and revenues generated from funds like the Inland Fisheries and Game Fund will be diverted into the state's "Rainy Day Reserve", thus making them available for any government use, not just those that would serve to benefit inland fisheries and forest reserves.

Perhaps the most devastating cut recommended in the 2004 budget is the proposal by Governor Romney to completely eliminate the Massachusetts Riverways program. Eliminating the Riverways program would severely inhibit the progress of river restoration and protection within the Neponset River Watershed and across the state. Action needs to be taken to protect this vital program in order to ensure that rivers continue to be protected and people continue to have the opportunities to utilize and enjoy these wonderful fresh water resources.

MA RIVERWAYS PROGRAM NEEDS YOUR HELP

The Massachusetts Riverways Program, that small and user-friendly state program that brings us Adopt-A-Stream, River Restore, the Urban Rivers program, technical assistance, and small grants, has been eliminated in the Governor's proposed budget for FY04 - starting July 1, 2003. We are asking for your help in restoring it.

As watershed associations working in partnership with citizens to protect local rivers and their watersheds, we all rely heavily on Riverways staff, train stream teams, work with us on dam issues, serve on our technical and advisory committees, give us "heads up" on issues we should pay attention to in our watershed, award small grants for our projects, and serve as a useful resource on all kinds of river issues.

Riverways is unique in state government: there is no other program like it. By encouraging local stewardship, Riverways leverages a very small state investment into a tremendous benefit for communities and employers statewide - producing more "bang per buck" than most other government programs. Ironically cutting this uniquely productive program only saves the Commonwealth \$360,000, but costs the state more than \$580,000 in services, because Riverways staff save so much of their budget through non-state grants. When choosing necessary budget cuts, it's critical that we preserve those programs that get the most done, with the fewest resources, through the Riverways.

Only your action can put this important program back in the state budget.

1. CALL OR WRITE (don't email) your state representative and senator and ask them to ask Representative Rogers (House Chair of Ways and Means) and Senator Therese Murray (Senate Chair of Ways and Means) to put Riverways back in the budget. You can find your legislator at www.whereitovotema.com/legsearch.php. To save Riverways requires only a \$360,000 line item, 10% less than was allocated last year. Last year (FY03) it was the item number 2300-0101.

2. Pass this information on to everyone that you know who cares about rivers - your neighbors, friends, and colleagues.

Be assured that this works! Legislators do listen to their constituents, and if they hear from enough of us, they'll act. Together we can make a difference for rivers and the environment!
