Conditions and Guidelines

Special grant-funded program, limited time only! Rebate applications accepted from February 24, 2020 through June 1, 2020. Only toilets replaced after February 24, 2020 are eligible.

Toilet must be WaterSense labeled. Look for the WaterSense logo at your retailer. Find independent third-party flush-power ratings at: www.map-testing.com/map-premium.html.

To maximize savings, consider models that use less than 1.28 gallons per flush (GPF), such as dual-flush and pressure assist models. Some models use as little as 0.65 GPF on average.

The applicant must be a residential water customer of record for an active, non-delinquent account. The toilet must be installed at the property where the water is delivered.

The property owner is solely responsible for ensuring proper installation and compliance with the Massachusetts plumbing code.

A copy of your receipt must accompany the rebate application.

Rebates of up to \$100 per toilet for purchase and installation costs will be issued as a credit on your next water bill.

Maximum of two toilet rebates per household. If you are a multi-family property owner and would like to request rebates for more than two toilets, please contact the office as such requests may be approved on a case by case basis as resources allow. Advance approval is always required for more than two toilet rebates.

The Town will perform a site visit to verify installation prior to issuance of a rebate.

The Town is not responsible for toilet performance or estimated savings, and does not provide any warranties or guarantees, express or implied.

Old toilets must not be reused and must be properly disposed of, recycled if possible. Disposal is the responsibility of the applicant.

The Town reserves the right to amend and/or discontinue this program without notice or when funding is exhausted.

This offer does not apply to new construction.
